All injuries between 6-30-85 and 11-19-87 will receive annual adjustments (based on the multiplier, capped at 5%) on the anniversary date of the injury, with the exception of those employees who are at maximum at the time of the injury. Employees at maximum at the time of injury receive their cost of living adjustments on July 1.

New maximums are effective August 1 beginning in 1988. If an employee is at maximum at the time of the injury, his/her comp rate (2/3 AWW, as adjusted) is adjusted on July 1st, but is subject to the Maximum Benefit Level. Min - \$25. Max – 53A in '91 Act.

Examples:

Employee not at max at time of injury receives COLA on anniversary date.

Employee at max at time of injury receives COLA on July 1 and max changes on August 1.

Injuries from 1-1-93 through 12-31-12:

Effective January 1, 1993 the maximum weekly benefit payable under Section 212, 213 or 215 is \$441 or 90% of the SAWW, whichever is higher. Beginning on July 1, 1994 the maximum benefit level is the higher of \$441 or 90% of the SAWW as adjusted annually utilizing the SAWW as determined by the Bureau of Employment Security. There is no provision in the Act for cost of living adjustments for injuries beginning on 1-1-93. There is no minimum payment amount.
