SUMMARY

The Travelers Insurance Group of affiliated companies (collectively Travelers) provides a wide variety of business insurance products including workers' compensation.

In April 2012, Travelers entered into an agreement with the Superintendent of the Maine Bureau of Insurance (Superintendent) and the Office of the Maine Attorney General for the purpose of bringing to a halt, without resort to an adjudicatory proceeding, violations of 39-A M.R.S.A. certified to the Superintendent by the Maine Workers' Compensation Board (Board) pursuant to Title 39-A M.R.S.A. Section 359(2). Regrettably, Travelers failed to fully meet compliance rates stipulated in the agreement and, therefore, voluntarily opted to pay a \$15,000 penalty in lieu of undergoing an expanded Look-Back review as ordered by the Superintendent in a letter dated April 1, 2015.

The Audit Division of the Board examined thirty-eight (38) claim files where indemnity benefits were paid for the period under examination (2020-2021) as well as fifty-nine (59) medical payments for the period under examination (2020-2021) to determine compliance with statutory and regulatory requirements in the following areas:

- > Form filing
- > Timeliness of benefit payments
- > Accuracy of benefit payments

The claim sample was drawn from a listing of all of Travelers' 2020-2021 Maine workers' compensation claims. The medical payment sample was drawn from a listing of all of Travelers' 2020-2021 medical payments for those claims in the sample.

Three (3) "Complaint for Audit" forms that named Travelers as the claims administrator were filed with the Audit Division since the last audit, but all issues raised by those documents were addressed and resolved by Travelers prior to this audit engagement. Therefore, those three (3) complaints were not included in this audit.

Due to questionable claims-handling techniques identified early in the audit process, this review was expanded to include a limited-scope audit of various claims with 2017–2021 dates of injury. These sixteen (16) claims were referred to Audit by the Board's Claims Management Unit due to Travelers' persistent unresponsiveness and/or delayed reactions regarding form filing requests. Of the claim files audited, there was one (1) 2017 claim, one (1) 2018 claim, four (4) 2020 claims and ten (10) 2021 claims. The audit of those claims addressed the following issues:

- Missing form filings
- > Form corrections

Travelers handles its Maine workers' compensation claims primarily in its New England claim center located in West Bridgewater, Massachusetts. Travelers also utilizes the services of Travis Gulliver as its claims agent within the State, although none of the claims under review were adjusted by Mr. Gulliver.

The audit work was conducted as a desk audit.

The compliance tables found on pages 21 through 26 of this report are representative of Board findings as of October 26, 2022. Since that time, the Audit Division has received additional information, missing form filings, form corrections, indemnity payments and adjustments. Based on this information, the Detailed Claims Information provided as an appendix of this report is representative of Board findings and updated form filings as of the issuance of this report.

Following is a discussion of the aforementioned compliance tables and of the steps taken since October 26, 2022 to rectify identified noncompliance issues. This discussion also includes other significant issues identified by the audit.

♦ Form filing

- Failure to file any Board form within established time frames is a violation of Title 39-A M.R.S.A. Section 360(1) (A) or (B).
- First Report of Occupational Injury or Disease (WCB-1):
 - ➤ Eleven (11) First Report of Occupational Injury or Disease forms were filed in accordance with the above requirements.
 - > Travelers' compliance rate for First Report of Occupational Injury or Disease filings is 29%, which is below the Board's performance benchmark of 85%.
 - > Twenty-seven (27) First Report of Occupational Injury or Disease forms were filed late.
- ➤ Wage Statement (WCB-2) and Fringe Benefits Worksheet (WCB-2B):
 - > Sixteen (16) Wage Statements and twelve (12) Fringe Benefits Worksheets were filed in accordance with the above requirements.
 - > Travelers' compliance rate for Wage Statement filings is 41%, which is below the Board's performance benchmark of 75%.
 - ➤ Travelers' compliance rate for Fringe Benefits Worksheet filings is 31%, which is below the Board's performance benchmark of 75%.
 - > Seventeen (17) Wage Statements and nineteen (19) Fringe Benefits Worksheets were filed late.

- > Six (6) Wage Statements and eight (8) Fringe Benefits Worksheets were required, but not filed.
 - ➤ Since October 26, 2022, Travelers submitted five (5) of those Wage Statements, and six (6) of those Fringe Benefits Worksheets.
- Memorandum of Payment (WCB-3 or WCB-4A) and Notice of Controversy (WCB-9):
 - > Twenty-two (22) Memorandum of Payment forms and four (4) Notice of Controversy ("lost time") forms were filed in accordance with the above requirements.
 - > Travelers' compliance rate for Memorandum of Payment filings is 55%, which is below the Board's performance benchmark of 85%.
 - > Travelers' compliance rate for Notice of Controversy filings is 100%, which is above the Board's performance benchmark of 90%.
 - Eighteen (18) Memorandum of Payment forms were filed late.
- ➤ Discontinuance of Compensation (WCB-4D or WCB-4A):
 - ➤ Eighteen (18) Discontinuance of Compensation forms were filed in accordance with the above requirements.
 - > Twelve (12) Discontinuance of Compensation forms were filed late.
 - > Two (2) Discontinuance of Compensation forms were required, but not filed.
 - ➤ Since October 26, 2022, Travelers submitted those two (2) Discontinuance of Compensation forms.
- ➤ Modification of Compensation (WCB-4M or WCB-4A):
 - > Five (5) Modification of Compensation forms were filed in accordance with the above requirements.
 - > Six (6) Modification of Compensation forms were filed late.
 - > Two (2) Modification of Compensation forms were required, but not filed.
 - ➤ Since October 26, 2022, Travelers submitted one (1) of those Modification of Compensation forms.

- ➤ (21 Day) Certificate of Discontinuance or Reduction of Compensation (WCB-8 or WCB-4A):
 - > Four (4) (21 Day) Certificate of Discontinuance or Reduction of Compensation forms were filed in accordance with the above requirements.
 - ➤ One (1) (21 Day) Certificate of Discontinuance or Reduction of Compensation form was required, but not filed.
- > Statement of Compensation Paid (WCB-11):
 - ➤ Thirty-eight (38) Statement of Compensation Paid forms were filed in accordance with the above requirements.
 - ➤ Eleven (11) Statement of Compensation Paid forms were filed late.
 - Eleven (11) Statement of Compensation Paid forms were required, but not filed.
 - ➤ Since October 26, 2022, Travelers submitted two (2) of those Statement of Compensation Paid forms.

♦ Timeliness of benefit payments

- Title 39-A M.R.S.A. Section 205(2) provides the time requirements for indemnity payments.
- ➤ When there is not an ongoing dispute, failure to pay weekly compensation benefits or accrued weekly benefits within 30 days after becoming due and payable is a violation of Title 39-A M.R.S.A. Section 205(2) and subject to penalty under Section 205(3).
- > Initial Indemnity Payments:
 - ➤ Thirty-two (32) initial indemnity payments were made timely.
 - > Travelers' compliance rate for initial indemnity payments is 74%, which is below the Board's performance benchmark of 87%.
 - Eleven (11) initial indemnity payments were made late.
 - Three (3) late initial indemnity payments were made later than 30 days after they became due and payable, in violation of Section 205(2) and subject to penalty under Section 205(3).
- ➤ Subsequent Indemnity Payments:
 - Five hundred sixty-three (563) subsequent indemnity payments were made timely.
 - > Seventy (70) subsequent indemnity payments were made late.
 - ➤ Three (3) late subsequent indemnity payments were made later than 30 days after they became due and payable in violation of Section 205(2) and subject to penalty under Section 205(3).
- ➤ Board Rules and Regulations Chapter 5 states in part, "The employer/insurer shall pay the health care provider's charge or the maximum allowable payment under this fee schedule, whichever is less, within 30 days of receipt of a bill unless the bill or previous bills from the same provider or the underlying injury has been controverted or denied. If an employer/insurer controverts whether a health care provider's bill is reasonable and proper under § 206 of the Act, the employer/insurer shall send a copy of the notice of controversy to the health care provider."
 - > Fifty-nine (59) medical payments were made timely.
- ➤ Title 39-A M.R.S.A. Section 324(1) provides the requirements for compensation payments per an approved agreement, order or decision. Board Rules and Regulations Chapter 8, Section 18.2 provides the requirements for compensation payments per a Consent Between Employer and Employee (WCB-4A).
 - ➤ Three (3) Consents Between Employer and Employee and one (1) Lump Sum Settlement were paid timely.

♦ Accuracy of indemnity payments

- ➤ Title 39-A M.R.S.A. Section 102(4) and Board Rules and Regulations Chapter 1, Section 5 provide the requirements for calculating average weekly wages (AWWs). Title 39-A M.R.S.A. Section 102(1) and Board Rules and Regulations Chapter 8, Section 9 provides the requirements for determining weekly compensation rates (WCRs). Title 39-A M.R.S.A. Sections 212, 213, and 215 provide the requirements for compensation for total incapacity, partial incapacity, and death benefits.
- > The accuracy of indemnity payments was reviewed for thirty-eight (38) claims.
- > Average Weekly Wage:
 - ➤ Twenty-three (23) AWWs were correct.
 - > Fifteen (15) AWWs were incorrect.
- ➤ Weekly Compensation Rate:
 - ➤ Twenty-three (23) WCRs were correct.
 - > Fifteen (15) WCRs were incorrect.
- > Partial Benefits Calculation Method:
 - > The method used to calculate partial benefits was correct for nine (9) claims.
 - > The method used to calculate partial benefits was incorrect for eight (8) claims.
- > Amount Paid:
 - > Twelve (12) claims were compensated correctly.
 - > Twenty (20) claims were underpaid (\$43,664.76 aggregately).
 - ➤ Since October 26, 2022, Travelers paid \$21,193.78 of the amounts due.
 - ➤ Six (6) claims were overpaid (\$1,297.69 aggregately).
 - ➤ Collectively, the aforementioned errors resulted in a net underpayment of \$42,367.07 to injured workers.

♦ Accuracy of medical payments

- ➤ Title 39-A M.R.S.A. Section 209-A and Board Rules and Regulations Chapter 5 provide the fee setting requirements for medical and ancillary services and products rendered by individual health care practitioners and health care facilities.
- > The accuracy of fifty-nine (59) medical payments was reviewed among nineteen (19) claims.
- > Amount Paid:
 - > Fifty-five (55) medical payments sampled were correct.
 - ➤ Four (4) medical payments sampled were incorrect.

♦ Other significant issues

- ➤ Boxes 19a and 19b of the WCB-4, Discontinuance or Modification of Compensation and/or Boxes 21a and 21b of the WCB-4D, Discontinuance of Compensation must accurately reflect the date the incapacity began (Boxes 19a and 21a) and/or ended (Boxes 19b and 21b). See the Board's Forms and Petitions Manual.
 - ➤ Incorrect dates were reported in Box 19a and/or 19b of the WCB-4, Discontinuance or Modification of Compensation and/or Box 21a and/or 21b of the WCB-4D, Discontinuance of Compensation forms filed for seven (7) claims.
- ➤ Box 22 (First Day Of Compensability After Waiting Period Is Met) of the WCB-3, Memorandum of Payment (MOP) must accurately reflect the date of the first compensable day that follows the completion of the 7-day waiting period. See the Board's Forms and Petitions Manual.
 - ➤ Incorrect dates were reported in Box 22 of the MOPs that were filed for thirteen (13) claims.
- ▶ Boxes 23a (Date of Incapacity) and 23b (Date Employer Notified) of the WCB-3, Memorandum of Payment (MOP) must accurately reflect the date of incapacity and date that the employer was notified of the incapacity. Note: the Date of Incapacity reported in Box 23a and the Date Employer Notified in Box 23b must equal the Date of Incapacity (DN56) and Date Employer Notified (DN281) reported in box 43 of the WCB-1, Employer's First Report of Occupational Injury or Disease (First Report). See the Board's Forms and Petitions Manual.
 - ➤ Incorrect dates were reported in Boxes 23a and/or 23b of the MOPs and/or 43a and/or 43b of the FROIs that were filed for nine (9) claims.
- ➤ Box 24 (Date Check Mailed) of the WCB-3, Memorandum of Payment (MOP) must accurately reflect the date that the initial indemnity payment (for the incapacity addressed by the MOP) is sent to the employee. See the Board's Forms and Petitions Manual.
 - Incorrect dates were reported in Box 24 of the MOPs that were filed for three (3) claims.
- Medical Treatment reported on the WCB-11, Statement of Compensation Paid form must not include allocated expenses. See the Board's Forms and Petitions Manual.
 - ➤ The auditor noted that allocated expenses were reported as Medical Treatment on the "Final" WCB-11s that were filed for three (3) claims.
- Additional payments were made since the "Final" WCB-11 Statement of Compensation Paid was filed for ten (10) claims.

♦ Limited-scope audit

Due to questionable claims-handling techniques identified early in the audit process, this review was expanded to include a limited-scope audit of various claims with 2017–2021 dates of injury. These sixteen (16) claims were referred to Audit by the Board's Claims Management Unit due to Travelers' persistent unresponsiveness and/or delayed reactions regarding form filing requests. The audit of those claims addressed the following issues:

PENALTIES

♦ Penalties payable to providers and/or injured employees

Title 39-A M.R.S.A. Section 205(3)

"When there is not an ongoing dispute, if weekly compensation benefits or accrued weekly benefits are not paid within thirty (30) days after becoming due and payable, \$50 per day must be added and paid to the worker for each day over thirty (30) days in which the benefits are not paid. Not more than \$1,500 in total may be added pursuant to this subsection. For purposes of ratemaking, daily charges paid under this subsection do not constitute elements of loss."
